Please read and complete this form with all necessary signatures. It is our expectation that students abide by all dance and school/district rules. By signing below both parent/guardian and student are acknowledging that they are aware that all school rules apply at this school event. Students who do not follow the dance guidelines and school/district rules will be asked to leave the dance. Alta Sierra wants to provide an environment where all students feel safe and that exemplifies character.

**Dance Rules**

1. **Each student must have this form filled out and have ready to be turned in to purchase a dance TICKET and must be in good standing. No suspensions for the semester.**
2. **Tickets may be purchased at the dance. To purchase a ticket a student must bring an ID Card, \$5.00 in cash; a Dance Contract signed by both student and parent.**
3. **Attire/Dress Code:** At *all* dances, students must be dressed appropriately. If a student has any questions or thinks an outfit may be questionable, please see Mrs. Martin in room 301 or Mr. Alvarez in the Kodiak Cluster office.
4. A student must always exhibit and maintain class and dignity, be polite, use appropriate language, and act and dance appropriately. Students who dance or behave inappropriately will be escorted out of the dance, parent/guardian will be called, and money will not be refunded.
  - a. Dancing may not be sexually explicit. This means no freaking, grinding, etc.
  - b. Dancing may not be dangerous. No moshing, slamming, getting on someone’s shoulders, etc.
  - c. Dancers must be vertical when dancing.
5. Alta Sierra is not responsible for any lost, stolen, or damaged items during the dance.
6. Students suspected of being in possession of a weapon, tobacco products, paraphernalia, or a controlled substance, and/or under the influence of a controlled substance may be in violation of the Zero Tolerance policy and will be subject to an investigation. If found to be in possession or under the influence, students will be removed from the dance immediately, face school disciplinary action and the matter will be referred to law enforcement.
