

CLOVIS WEST HIGH SCHOOL DANCE CONTRACT
"Fall Harvest Dance"

Where: Clovis West High School Baseball Diamond
When: Saturday, November 6th, 2021
Time: 7:00 P.M. – 9:00 P.M.; No admittance after 7:30 P.M. Students may not leave until 8:30 P.M unless picked up by each student's parent/guardian. Students must be picked up by 9:30 PM or they will not be allowed to attend the next dance.

Please read (student and parent/guardian) and complete this form with all necessary signatures. It is our expectation that students abide to dance and school rules and regulations. By signing below both parent and student are acknowledging they are aware that all school rules apply as this is a school event. If students choose not to follow the dance guidelines and normal school rules, students will be asked to leave the dance. In such case parents will be notified and the student's actions could warrant additional school consequences. Clovis West wants to provide an environment where all students feel safe in a non-hostile and respectful environment that exemplifies CWHS character and class.

1. Each student (student and student's date) must have this form filled out and turned in to buy a bid and must be in good standing (not owe any hours to the SRC or and not be on the non-privilege list).
 - a. If you are bringing a guest, your guest pass **must be** turned in to SRC for approval of guests.
 - b. Max age of a guest is 20 years of age
2. Each student must have a current student ID card in order to buy a bid and when checking in at the dance.
 - a. **Students without an ID card will not be admitted to the dance. Students without an ID can use their driver's license or government ID due to covid-19.**
 - b. Approved guests may use their driver's license but must have a photo ID as well.
3. During dances and all activities, we require our students and their guests to dress and act with respect and dignity. School dress code policies apply at all times to students and guests (even non-CW students must shave facial hair). With the exception of strapless dresses for formal or prom, dresses/slits in the dress may be no more than 6" above the knee. Please ask Mrs. Harris-Trotter in the SRC if you have any questions or think your outfit may be questionable. **If a student and/or guest are dressed inappropriately, he/she will be asked to leave/denied entrance and money will not be refunded.**
4. A student and his/her guest must always exhibit and maintain class and dignity, be cordial, use appropriate language and act and dance appropriately. Students who dance or behave inappropriately will be escorted out of the dance, parents will be called, and the student will not be given a refund.
 - a. Dancing may not be sexually explicit. This means no freaking, grinding, groping, etc. No making out.
 - b. Dancing may not be dangerous. This means no moshing, slamming, getting on someone's shoulders, etc.
 - c. Dancers must be vertical when dancing with someone.
5. **Clovis West is not responsible for any lost or stolen items during the dance. If you do not want something lost or stolen, do not bring it to the dance.**
6. **Students suspected of being under the influence of drugs, controlled substances and/or alcohol may be subject to an evaluation (breathalyzer test, etc.). If found to be under the influence of a controlled substance, students will face school disciplinary action and the matter will be referred to law enforcement.**
7. **Bids are non-refundable and non-transferable. Please plan accordingly when buying a bid.**
8. **A student that tests positive for Covid-19 will receive a full refund of bid.**
9. **Students must follow current county protocols regarding Covid-19 Safety Guidelines (masks & social distancing)**

I understand and agree that, as a condition of buying a bid and attending Clovis West dances, I must abide by the above expectations for dress and behavior. I understand there will be consequences for behavior and zero tolerance violations which could result in losing senior privileges, detention, suspension and/or expulsion. I also understand and agree that I will accept and support the decision of the administration as they interpret expectations.

CLOVIS WEST HIGH SCHOOL GUEST PASS Procedure

- * Guest passes will be available from the Activities Office beginning October 18th, 2021.
- * Guest pass must be returned to the SRC office for final signature/approval by October 27th @ 3:00PM.
- * CWHS student and quest will complete information on pass.
- * CWHS student and quest will obtain appropriate signatures and attach a business card from the quest's school administrator.

DANCE POLICY

- * Guest **MUST** adhere to all CUSD dress code policies. No Exceptions
- * Guest **MUST** have approved guest pass and photo ID.
- * The guest may not exceed 20 years of age.
- * Students must show valid ID card to enter.
- * Students must have bid to enter dance.
- * Only 1 guest per student
- * Guests age 18 and under must be enrolled in an educational institution for verification purposes.

AT THE EVENT

- * Students must drive or be picked up by parent or guardian by 9:30PM from the dance. If students are not picked up by 9:30PM students will not be allowed to attend the next dance.
- * Clovis West Students and their quest **MUST** be in Clovis Unified School District Dress Code.
- * If any party is under the influence of alcohol or drugs, the CWHS parent will be contacted and requested to pick up the student and/or quest immediately. If unable to make parent contact, the student and quest found to be under the influence will be turned over to the police.
- * Along with the quest pass, the quest will present valid school photo ID or valid driver's license.
- * Any violation of school rules, the CWHS parent will be contacted to pick up the student and/or quest.
- * To provide a safe and positive environment at school events, Clovis West High School reserves the right to deny admission to anyone regardless of approval of home school. IF CLEARANCE AT THE DOOR IS NOT VALID, COUPLE MAY NOT BE ADMITTED.
- * Guests must also follow current county guidelines for safe practice surrounding Covid-19.
- * Guests that are NOT CUSD will need to bring proof of negative Covid test within 72 hours of the dance to the Deputy Principal office.
- * All current CUSD students will be provided a Covid test appointment.
